UNIVERSITIES ACT, No. 16 OF 1978

Order under Section 25A

BY virtue of powers vested in me by Section 25A of the Universities Act, No. 16 of 1978 I, Dr. Sarath Amunugama, the Minister of Higher Education and Research, having obtained a report under Section 70 C of the aforesaid Act, in respect of the South Asian Institute of Technology and Medicine (Pvt.) Ltd. (SAITM) a company incorporated in Sri Lanka under the Companies Act, No. 7 of 2007 and bearing Registration Number PV 64641, do by this Order and subject to the conditions specified in Schedule I hereto, recognize the South Asian Institute of Technology and Medicine (Pvt.) Ltd. (SAITM) as a Degree Awarding Institute for the purpose of developing higher education therein, leading to the award of the Degrees specified in Column I of the Schedule II hereto, of which the abbreviations are set out in the corresponding entries respectively in Column II of the Schedule II hereto.

SCHEDULE I

CONDITIONS

- (1) SAITM - South Asian Institute of Technology and Medicine (Pvt.) Limited (hereinafter referred to as the "Institute") shall before the expiry of two months from the date of granting the degree awarding status, submit its Article of Association duly amended as set out below to the specified Authority :-
 - (a) to specify higher education as an object in the Article of Association ;
 - (b) to undertake to inform the Specific Authority of Voluntary winding up of the Company prior to such winding up.
- (2) The Institute shall before the expiry of Twelve months (12) from the date of granting the degree awarding status, submit the following details to Specified Authority :-
 - (i) proof of recruitment of qualified academic and non-academic staff as to meet the requirements of the relevant degree programme ;



- (ii) a study program for the specified period of study in accordance with the norms approved by the University Grants Commission ;
- (iii) proof of the availability of the text books, hand books, recommended reading books and other sufficient learning materials required for the relevant degree programme ;
- (iv) proof of availability of spacious modernized library with all required collection of books and materials, which would enable students who carry out and the required of researches for the relevant degree programme ; and
- (v) specifying the requirement for the staff to engage in relevant researches and publish such researches in journals in Sri Lanka.
- (3) The Institute shall before the expiry of 03 years from the date of granting the degree awarding status, establish the following laboratories required to the Engineering Bachelor of Science (Hons.) in Civil Engineering Degree Programme.
- (i) Material and Mechanics Laboratory,
- (ii) Surveying Laboratory,
- (iii) Structural Testing Laboratory,
- (iv) Geotechnical Laboratory,
- (v) Hydraulic Laboratory.
- (4) Establishment of Laboratories : SAITM shall increase following laboratory facilities before completion of second academic year of the first batch of student enrolment and obtain approval of specified Authority :
- (i) Robotics and Artificial Intelligence Lab
- (ii) Industrial Automation and Process Control Lab
- (iii) Electronics, Instrumentation and Power System Lab
- (iv) Engineering Workshop.
- (5) Evidence of Quality Assurance Mechanism implementation shall be submitted on an half yearly basis and full implementation evidence shall be submitted within one year of enrolling first batch.
